**Minutes**

On a motion from Joyce Sniff, seconded by Norma Craddock, the minutes for the October 8, 2024, called meeting was approved as submitted. Vote 4-0

On a motion from Lillian Sanders, seconded by Norma Craddock, the minutes for the October 17, 2024, regular meeting was approved as submitted. Vote 4-0

**General Fund Financial Report**

On a motion from Norma Craddock, seconded by Lillian Sanders, the October 2024 General Fund Financial Report was approved as submitted. Vote 4-0

**Water Fund Financial Report**

On a motion from Joel Kriner, seconded by Joyce Sniff, the October 2024 Water Fund Financial Report was approved as submitted. Vote 4-0

**Water Department Report**

Water Superintendent, Adam Boswell, was not present at the meeting. George Spearing III said that all wells were running well. He and Adam have been trying to reach the EPD for the well protection plan. He said he was going by there tomorrow and will go see them.

Joel Kriner asked if Georgia Power got the power to the Meyer Farm Road well. Mr. Spearing III said that it is not online yet.

Mayor Morcom said that Adam Boswell mentioned adding another water tank in the next 3 to 4 years.

Sasha White was present to ask the council for a reduction on her water bill due to a leak that had occurred during the month of the increased rates. According to her, the leak had been repaired. The council reduced her water bill back down to the normal rates.

### **Fire Department**

Arnoldsville Fire Chief, Heath Baker, was not present at the meeting. Doug Cosby said that there were two brush fire calls and that the Barbecue Fundraiser and 50/50 Raffle were a success.

The tanker is in, and they are working on getting it certified. They have a new garage door and are replacing the 3<sup>rd</sup> door down. They are turning the meeting area into a bay.

### **Zoning**

Land Use/Zoning Officer Lynn Shedd reported that he had one building permit.

### **New Business**

Mayor Danny Morcom said that House bill 1022 (milage rate) was out and that the council needed to either opt in or opt out. It is due in March. The county told Mayor Morcom that the schools could not exceed 20 mills.

Lillian Sanders said that someone had contacted her about a neighbor burning trash in their yard daily. They do it late at night and it smells like plastic and household trash burning.

Land Use/Zoning Officer Lynn Shedd said it was illegal to burn in the city. Mayor Morcom asked Lillian Sanders to get a time and address of the property.

### **Old Business**

City Attorney, Danny Love, said he is working on the emergency water masterplan.

The Christmas Party is at the Arnoldsville Baptist Church on Saturday, December 14<sup>th</sup> at 6pm. Adam Boswell's son will be singing. The council asked that an invitation be put in all the bills and emails.
